The amendment includes: <ul style="list-style-type: none"><li>– Removal of <i>Anthracoystis destruens</i> (synonyms <i>Sporisorium destruens</i> and <i>Ustilago destruens</i>) from the pest list for <i>Panicum</i> spp.;</li><li>– Removal of the requirements to manage this pest.</li></ul>
