Description of content:</b> The draft regulation aims at using a phytosanitary risk assessment system when selecting control procedures for quarantine phytosanitary control, as well as at uniform decision-making in relation to batches of products subject to phytosanitary control if there is a discrepancy between the phytosanitary certificate and shipping documents and if quarantine organisms are detected.
