Description of content: The objective of the notified document PMRL2023-21 is to consult on the listed maximum residue limits (MRLs) for clopyralid that have been proposed by Health Canada's Pest Management Regulatory Agency (PMRA). <u>MRL (ppm)¹ Raw Agricultural Commodity (RAC) and/or Processed Commodity</u> 0.4 Bulb onions (crop subgroup 3-07A) 0.1 Bushberries (crop subgroup 13-07B) ² ¹ ppm = parts per million ² An MRL of 0.1 ppm is currently established for "blueberries". This MRL will be expired, as the individual commodities of highbush blueberries and lowbush blueberries (both terms reflect current crop terminology) will be covered by the proposed MRL on Bushberries (crop subgroup 13-07B).
