The following communication, received on 3 May 2023, is being circulated at the request of the Delegation of <u>Canada</u>.

Established Maximum Residue Limit: Fluopyram

The proposed maximum residue limit (PMRL) document for fluopyram notified in G/SPS/N/CAN/1473 (dated 30 January 2023) was adopted 25 April 2023. The proposed MRL was established via entry into the Maximum Residue Limits Database and is provided directly below:

MRL (ppm)¹ Raw Agricultural Commodity (RAC) and/or Processed Commodity

15 Serpent garlic scapes

¹ ppm = parts per million
