#### Addendum

The following communication, received on 10 May 2023, is being circulated at the request of the Delegation of <u>Canada</u>.

#### Established Maximum Residue Limit: Pyriproxyfen

The proposed maximum residue limit (PMRL) document for pyriproxyfen notified in G/SPS/N/CAN/1475 (dated 6 February 2023) was adopted 3 May 2023. The proposed MRL was established via entry into the Maximum Residue Limits Database and is provided directly below:

MRL (ppm)<sup>1</sup> Raw Agricultural Commodity (RAC) and/or Processed Commodity
0.2 Bananas
