#### Addendum

The following communication, received on 17 May 2023, is being circulated at the request of the Delegation of <u>Canada</u>.

## Established Maximum Residue Limit: Benoxacor

The proposed maximum residue limit (PMRL) document for benoxacor notified in G/SPS/N/CAN/1481 (dated 21 February 2023) was adopted 15 May 2023. The proposed MRL was established via entry into the Maximum Residue Limits Database and is provided directly below:

MRL (ppm)<sup>1</sup> Raw Agricultural Commodity (RAC) and/or Processed Commodity

0.01 Caneberries (crop subgroup 13-07A)
