#### Addendum

The following communication, received on 22 May 2023, is being circulated at the request of the Delegation of <u>Canada</u>.

### Established Maximum Residue Limits: Florpyrauxifen-benzyl

The proposed maximum residue limit (PMRL) document for florpyrauxifen-benzyl notified in G/SPS/N/CAN/1468 (dated 20 December 2022) was adopted 16 May 2023. The proposed MRLs were established via entry into the Maximum Residue Limits Database and are provided directly below:

## MRL (ppm)<sup>1</sup> Raw Agricultural Commodity (RAC) and/or Processed Commodity

0.06 Meat by-products of cattle, goats, horses and sheep

0.02 Root and tuber vegetables (crop group 1); legume vegetables (crop group 6-21); cereal grains (crop group 15-21); oilseeds (crop group 20) (revised); fat and meat of cattle,

grains (crop group 15-21); oilseeds (crop group 20) (revised); fat and meat of cattle
