The following communication, received on 25 May 2023, is being circulated at the request of the Delegation of <u>Canada</u>.

Established Maximum Residue Limits: Teflubenzuron

The proposed maximum residue limit (PMRL) document for teflubenzuron notified in G/SPS/N/CAN/1483 (dated 23 February 2023) was adopted 18 May 2023. The proposed MRLs were established via entry into the Maximum Residue Limits Database and are provided directly below:

MRL (ppm)¹ Raw Agricultural Commodity (RAC) and/or Processed Commodity

- 6.0 Dried apples
- 1.0 Raisins
- 0.7 Grapes
- 0.5 Apples
- 0.3 Cantaloupes, muskmelons (other than those listed in this item)
- 0.01 Sugarcane cane
