The Draft Resolution 1143, 9 February 2023 - previously notified through G/SPS/N/BRA/2132 - which is regarded the proposal for inclusion of active ingredients B26 - BIFENTRINE, F74 - PHENPROPIDINE, I13 - IMIDACLOPRID, I26 - IPCONAZOLE, M17 - METOMYL, M31 - METALAXYL - M, P61 - PYROXASULPHONE, S13 - S-METOLACCHLOR, T12 - TIABENDAZOLE, T39 - TERBUTYLAZINE, T70 - TOLFENPIRAD, and Z04 - ZOXAMIDEon the Monograph List of Active Ingredients for Pesticides, Household Cleaning Products and Wood Preservers, published by Normative Instruction 103 - 19 October 2021 on the Brazilian Official Gazette (DOU - Diário Oficial da União), was adopted as the Normative Instruction 227, 1 June 2023.
