Removal of <i>Liposcelis entomophila</i> (<i>Liposcelis entomophilus</i>) from the pest list for <i>Zea mays</i> ; b. Removal of <i>Dinoderus minutus</i> from the pest list for <i>Zea mays</i> ; c. Removal of Tomato black ring virus (TBRV) from the pest list for <i>Phaseolus</i> spp.
