6.	Description of content: This draft report determines that the importation of commercially produced passionfruit (<i>Passiflora edulis</i>) to Australia from all commercial production areas of Vietnam can be permitted, subject to a range of biosecurity requirements.
	The draft report contains details of pests that are of biosecurity concern to Australia that are potentially associated with the importation of commercially produced passionfruit from Vietnam, the risk assessments for the identified quarantine pests, and the proposed risk management measures to reduce biosecurity risks to an acceptable level.
