The following communication, received on 18 July 2023, is being circulated at the request of the Delegation of <u>Canada</u>.

Established Maximum Residue Limits: Mandestrobin

The proposed maximum residue limit (PMRL) document for mandestrobin notified in G/SPS/N/CAN/1500 (dated 3 May 2023) was adopted 17 July 2023. The proposed MRLs were established via entry into the Maximum Residue Limits Database and are provided directly below:

MRL (ppm)¹ Raw Agricultural Commodity (RAC) and/or Processed Commodity

4.0 Leaf lettuce 0.08 Head lettuce ¹ ppm = parts per million
