Draft Resolution 1157, 6 April 2023

Draft Resolution 1157, 6 April 2023 - previously notified through G/SPS/N/BRA/2157 - was adopted as Normative Instruction 233, 1 August 2023. The regulation amends the monographs of the active ingredients B41 - Boscalid, C07 - Kasugamycin, C10 - Cypermethrin, C18 - Chlorothalonil, C25 - Cartap Hydrochloride, C32 - Clethodim, C55 - Copper-based compounds, C63 - Lambda-Cyhalothrin, D06 - Deltamethrin, D21 - Diquat, G05 - Ammonium Glufosinate, H07 - Methyl Haloxyp-P, I12 - Imazapyr, I20 - Imazapik, I30 - Impirfluxam, M45 - Mandipropamide, O21 - Oxathiapiprolone, P23 - Propamocarb, S13 - S-Metolachlor, T14 - Methyl Thiophanate, T48 - Thiamethoxam on the Monograph List of Active Ingredients for Pesticides, Sanitizing Disinfectants and Wood Preservatives, published by Normative Instruction 103, 19 October 2021, in the Brazilian Official Gazette (DOU - Diário Oficial da União).
