### *Addendum*

The following communication, received on 11 September 2023, is being circulated at the request of the Delegation of Brazil.

#### Draft Resolution 1167, 18 May 2023

Draft Resolution 1167, 18 May 2023 - previously notified through G/SPS/N/BRA/2169 - was adopted as Normative Instruction 251, 1 September 2023. The regulation updates the monographs of the active ingredient T81 - TOLPIRALATE on the Monograph List of Active Ingredients for Pesticides, Household Cleaning Products and Wood Preservatives, published by Normative Instruction 103 on 19 October 2021 in the Brazilian Official Gazette (DOU - Diário Oficial da União).
