Addendum

The following communication, received on 15 September 2023, is being circulated at the request of the Delegation of <u>Canada</u>.

Established Maximum Residue Limits: Flumioxazin

The proposed maximum residue limit (PMRL) document for flumioxazin notified in G/SPS/N/CAN/1515 (dated 30 June 2023) was adopted 10 September 2023. The proposed MRLs were established via entry into the Maximum Residue Limits Database and are provided directly below:

- <u>MRL (ppm)</u>¹ <u>Raw Agricultural Commodity (RAC) and/or Processed Commodity</u>
- 0.02 Edible-podded dwarf peas, edible-podded peas, edible-podded pigeon peas, ediblepodded snow peas, edible-podded sugar snap peas, succulent shelled English peas, succulent shelled garden peas, succulent shelled green peas, succulent shelled peas, succulent shelled pigeon peas
