Addendum

The following communication, received on 15 September 2023, is being circulated at the request of the Delegation of Canada.

Established Maximum Residue Limits: Cyflumetofen

The proposed maximum residue limit (PMRL) document for cyflumetofen notified in G/SPS/N/CAN/1512 (dated 21 June 2023) was adopted 13 September 2023. The proposed MRLs were established via entry into the Maximum Residue Limits Database and are provided directly below:

<u>MRL (ppm)¹</u>	<u>Raw Agricultural Commodity (RAC) and/or Processed Commodity</u>
30	Hops (dried cones)
1.5	Cherries (crop subgroup 12-09A)
0.4	Peaches (crop subgroup 12-09B)
0.3	Plums (crop subgroup 12-09C)

¹ ppm = parts per million
