Draft Resolution 1169, 1 June 2023

Draft Resolution 1169, 1 June 2023 - previously notified through G/SPS/N/BRA/2174 - was adopted as Normative Instruction 255, 27 September 2023. The regulation is regarded the proposal for inclusion of active ingredients B29 – BUPROFEZINE, B46 – BENZOVINDIFLUPIR, B55 – EMAMECTIN BENZOATE, C36 – CYPROCONAZOLE, C60 – ZETA - CYPERMETHRIN, D36 – DIPHENOCONAZOLE, E33–SPYROPIDIONE, G05 – AMMONIUM GLUFOSINATE, I21 – INDOXACARB, I32 – ISOCYCLOSERAM, M47 – MELALEUCA ALTERNIFOLIA, N09 – NOVALUROM, P13 – PROFENOPHOS, P34 – PYRIPROXIFEM, P36 – PENCICUROM and T56 – TRINEXAPAQUE ETHY on the Monograph List of Active Ingredients for Pesticides, Household Cleaning Products and Wood Preservatives, published by Normative Instruction 103 on 19 October 2021 in the Brazilian Official Gazette (DOU - Diário Oficial da União).
