Description of content: Health Canada's Food Directorate completed a premarket safety assessment of a food additive submission seeking authorization for the use of cellulase from <i>Trichoderma reesei</i> RF11412 in brewers' mash and distillers' mash. The requested maximum level of use for this food enzyme is "Good Manufacturing Practice". The results of the premarket assessment support the safety of cellulase from <i>T. reesei</i> RF11412 for its requested uses. Consequently, Health Canada has enabled the use of cellulase from this source as described in the information document by modifying the <i>List of Permitted Food Enzymes</i> , effective 11 October 2023. The purpose of this information document is to publicly announce the Department's decision in this regard and to provide the appropriate contact information for those wishing to submit an inquiry or new scientific information relevant to the safety of this food additive. |
