An application was submitted for the reauthorisation of these substances in accordance with article 10 of Regulation (EC) No. 1831/2003. Further to the positive assessment by the European Food Safety Authority, these substances are reauthorised as feed additives for all animal species, under certain conditions. A transitional period is included for the interested parties to meet the new authorisation's requirements.
