The amendment includes: removing phytosanitary measures for the following fungal pathogens for imported hulled hemp seeds: a) <i>Curvularia cymbopogonis</i> ; b) <i>Leptosphaeria woroninii</i> ; c) <i>Septoria cannabis</i> .
