6.	<b>Description of content:</b> The notified draft measure establishes: <ul style="list-style-type: none"><li>– Phytosanitary requirements for canola (<i>Brassica napus</i> L.) seeds produced in Uruguay and the United States;</li><li>– Requirements for <i>Trogoderma granarium</i> contained in grains for consumption of coriander (<i>Coriandrum sativum</i>), millet (<i>Pennisetum glaucum</i>, <i>Pennisetum miliaceum</i>) nutmeg (<i>Myristica fragrans</i>) and pepper (<i>Piper nigrum</i>);</li><li>– Phytosanitary requirements for grain species only if contained in mixtures for animal feed (pets);</li><li>– An additional declaration for countries to declare that a pest is not present in the country of origin, following the guidelines of ISPM 8.</li></ul> Further details can be found in the document attached to this notification.
