This regulation lays down animal health conditions for the movement and importation from other countries of live Equidae. It describes rules for the movement of Equidae from different countries, their import to Albania, identification of African Equidae disease and test for the diagnosis, tests procedures, tests results, diseases that must be notified and import model of veterinary health certificate for Equidae.
