**6. Description of content:** This Order of the Minister has been approximated with Council Directive of 25 September 1989 on animal health conditions governing intra-Community trade in and importation from third countries of embryos of domestic animals of the bovine species (89/556/EEC).

This regulation defines the animal health conditions governing trade in and importation from other countries of fresh and frozen embryos of domestic animals of the bovine species. It describes health conditions that affect trade and use of embryos of live bovine animals, collections, transport, processing and storage of bovine embryos and the model of veterinary health certificate of bovine embryos.
