Description of content: This standard specifies requirements, sampling and test methods of: i) broadleaved (Batavian) endives (escaroles) of varieties <i>Cichorium endivia</i> var. <i>latifolium</i> Lam; ii) curled-leaved endives of varieties <i>Cichorium endivia</i> var. <i>crispum</i> Lam; and iii) other lettuces of varieties; <i>Lactuca sativa</i> var. <i>capitata</i> L. (head lettuces including crisp-head and "Iceberg" type lettuces), <i>Lactuca sativa</i> var. <i>longifolia</i> Lam. (cos or romaine lettuces), <i>Lactuca sativa</i> var. <i>crispa</i> L. (leaf lettuces) and crosses of these varieties to be supplied fresh to the consumer after preparation and packaging. This standard does not apply to produce for industrial processing, produce presented as individual leaves, lettuces with root ball or lettuces in pots. This Draft African Standard was also notified under TBT Committee.
