Description of content:</b> This notification is further to the SPS Notification (G/SPS/N/CAN/597/Add.2), where the Minister of Health has issued a Ministerial Regulation entitled " <i>Marketing Authorization (MA) for Maximum Residue Limits (MRLs) for Veterinary Drugs in Foods</i> " pursuant to section 30.3(1) and 30.5(1) of the <i>Food and Drugs Act</i> .  The online " <i>List of Maximum Residue Limits (MRLs) for Veterinary Drugs in Foods</i> " <a href="http://www.hc-sc.gc.ca/dhp-mps/vet/mrl-lmr/mrl-lmr_versus_new-nouveau-eng.php">http://www.hc-sc.gc.ca/dhp-mps/vet/mrl-lmr/mrl-lmr_versus_new-nouveau-eng.php</a> (referred hereafter as the List) is incorporated by reference and is maintained on Health Canada's website.
