#### Draft Resolution 1189, 3 August 2023

Draft Resolution 1189, 3 August 2023 - previously notified through G/SPS/N/BRA/2200 - was adopted as Normative Instruction 274, 21 February 2024. The regulation establishes technological functions, maximum limits, and conditions of use for food additives.
