Description of content: The objective of the notified document PMRL2016-61 is to consult on the listed domestic maximum residue limits (MRLs) for spirotetramat that have been proposed by the Health Canada's Pest Management Regulatory Agency (PMRA). <u>MRL (ppm)</u> <u>Raw Agricultural Commodity (RAC) and/or Processed Commodity</u> 2.0 Caneberries (Crop Subgroup 13-07A) ppm = parts per million MRLs are proposed for each commodity included in the listed crop groupings in accordance with the <i>Residue Chemistry Crop Groups</i> webpage (http://www.hc-sc.gc.ca/cps-spc/pest/part/protect-proteger/food-nourriture/rccg-gcpcr-eng.php) in the Pesticides and Pest Management section of Health Canada's website.
