The following communication, received on 21 March 2024, is being circulated at the request of the Delegation of <u>Canada</u>.

Established Maximum Residue Limit: Dimethenamid

The proposed maximum residue limit (PMRL) document for dimethenamid notified in G/SPS/N/CAN/1542 (dated 5 January 2024) was adopted 19 March 2024. The proposed MRL was established via entry into the Maximum Residue Limits Database and is provided directly below:

MRL (ppm)¹ Raw Agricultural Commodity (RAC) and/or Processed Commodity

0.01 Horseradish roots

MRLs established in Canada may be found using Health Canada's *Maximum Residue Limit Database* (https://pest-control.canada.ca/pesticide-registry/en/mrl-search.html) on the *Maximum residue limits*, *human health*, and food safety webpage (https://www.canada.ca/en/health-canada/services/consumer-product-safety/pesticides-pest-management/public/protecting-your-health-environment/pesticides-food/maximum-residue-limits-pesticides.html).
