The following communication, received on 22 May 2024, is being circulated at the request of the Delegation of Brazil.

Draft Resolution 1228, 18 January 2024

Draft Resolution 1228, 18 January 2024 - previously notified through G/SPS/N/BRA/2252 - was adopted as Normative Instruction 299, 17 May 2024. The regulation proposes the inclusion of active ingredient C88 - CYCLOBUTRIFLURAM on the Monograph List of Active Ingredients for Pesticides, Household Cleaning Products and Wood Preservatives, which was published by Normative Instruction 103 on 19 October 2021 in the Brazilian Official Gazette (DOU - Diário Oficial da União).
