- **6. Description of content:** The notified Resolution suspends the issuance of animal health documents for the importation of at-risk production mammals, and products and byproducts thereof, capable of transmitting avian influenza and coming from countries, regions, states and/or areas that have reported the presence of highly pathogenic avian influenza (HPAI) in production mammals. The suspension will remain in place until an assessment has been conducted to determine whether to establish permanent measures or to amend or lift the measures adopted in the notified Resolution.
- 7. Objective and rationale: [] food safety, [X] animal health, [] plant protection, [X] protect humans from animal/plant pest or disease, [] protect territory from other damage from pests.
- 8. Nature of the urgent problem(s) and reason for urgent action: In the light of the increase in the presence of HPAI in various species of mammals, it has become necessary to maintain strict surveillance of domestic and wild birds and to take preventive and surveillance measures in relation to other susceptible animal species, such as production mammals, in order to prevent outbreaks and detect, in a timely manner, any unusual presentation of the disease in Colombian livestock. These measures have been adopted in application of the precautionary principle, underpinned primarily by the scientific uncertainty surrounding this public health warning.
