Description of content:</b> The substance specified in this Act was initially authorized for a period of ten years as a feed additive for all animal species in the category 'technological additives' and in the functional group 'silage additives'. An application was submitted for the renewal of this authorization. Further to the favourable assessment by the European Food Safety Authority, the authorization of this substance is renewed, subject to certain conditions.
