Description of content: The substances specified in this Act were initially authorized for a period of ten years as feed additives for all animal species in the category 'nutritional additives' and in the functional group 'vitamins, pro-vitamins and chemically well-defined substances having similar effect'. An application was submitted for the renewal of this authorization. Further to the favourable assessment by the European Food Safety Authority, the authorization of these substances is renewed, subject to certain conditions.
