CIRCULAR

Amending, supplementing a number of articles of Circular No. 13/2016/TT-BNNPTNT dated 02/6/2016 of the Minister of Agriculture and Rural Development Regulations on the management of veterinary drugs

Pursuant to the Government's Decree No. 105/2022/ND-CP dated December 22, 2022 stipulating the functions, tasks, powers and organizational structure of the Ministry of Agriculture and Rural Development;

Pursuant to the 2015 Law on Veterinary Health;

At the request of the Director General of the Department of Veterinary Health:

The Minister of Agriculture and Rural Development promulgates a Circular amending and supplementing a number of articles of Circular No. 13/2016/TT-BNNPTNT dated 02/6/2016 of the Minister of Agriculture and Rural Development regulating the management of veterinary medicines.

Article 1. Amending and supplementing a number of articles of Circular No. 13/2016/TT-BNNPTNT dated June 02, 6 of the Minister of Agriculture and Rural Development regulating the management of veterinary medicines

- 1. Clause 5 Article 20 is amended and supplemented (supplemented in Clause 1 Article 1 of Circular No. 18/2018/TT-BNNPTNT) as follows:
- "5. The assessment of the conformity of domestically produced veterinary medicine products shall comply with method 1 specified in Circular No. 28/2012/TT-BKHCN dated December 12, 12 of the Minister of Science and Technology stipulating the announcement of standard conformity, announcement of conformity with regulations and methods of assessing conformity with standards, technical regulations (hereinafter abbreviated as Circular No. 28/2012/TT-BKHCN)".
- 2. Clause 5 Article 34 (amended and supplemented in Clause 11 Article 1 of Circular No. 18/2018/TT-BNNPTNT) is amended as follows:
- "5. The conformity assessment of imported veterinary drug products shall be carried out according to method 1 specified in Circular No. 28/2012/TT-BKHCN".

Article 2. Enforcement Terms

1. This Circular takes effect from date month year 2024.

- 2. Transitional provisions
- a) Veterinary medicine products that have been certified in conformity with the National Technical Regulation on Veterinary medicines General Requirements (QCVN 01-187:2018/BNNPTNT) by method 2 or method 5 specified in Circular No. 28/2012/TT-BKHCN before the effective date of this Circular, continue to complete procedures for announcement of conformity with regulations as prescribed by law;
- b) A dossier of registration for announcement of veterinary medicine regulation conformity submitted to the Department of Animal Health before the effective date of this Circular shall continue to be appraised by the Department of Animal Health and issued a notice of receipt of the dossier of announcement of veterinary medicine regulation conformity in accordance with law at the time of submission.
- c) For veterinary medicine quality test slips that fully meet the criteria specified in the National Technical Regulation on Veterinary Medicines QCVN 01-187:2018/BNNPTNT issued by a designated testing organization, before the effective date of this Circular, this test slip may be used to carry out procedures for announcement of regulation conformity.
- 3. The Director General of the Department of Animal Health, Heads of units under the Ministry and relevant organizations and individuals shall be responsible for the implementation of this Circular.

In the course of implementation, if there are problems or need to be amended or supplemented, agencies, organizations and individuals are requested to promptly report to the Ministry of Agriculture and Rural Development (through the Department of Animal Health) for consideration and resolution./.
