An application was submitted for the reauthorization of this substance in accordance with article 10 of Regulation (EC) No 1831/2003. Further to the positive assessment by the European Food Safety Authority, this substance is reauthorized as feed additive for all animal species, in the category 'technological additives' and the functional group 'binders', under certain conditions. A transitional period is included for the interested parties to meet the new authorization's requirements.  |
