Draft Resolution 1232, 2 February 2024

Normative Instruction 300, 17 May 2024 - previously notified through G/SPS/N/BRA/2250/Add.1 - was rectified. This normative instruction updates the monographs of the active ingredients A02 - Acephate, A12 - Asulam, A26 - Azoxystrobin, A29 - Acetamiprid, A54 - Azadirachtin, B26 - Bifentrin, B39 - Benzyladenine, B41 - Boscalid, B68 - Bixlozone, C10 - Cypermethrin, C35 - Chlomazone, C36 - Cyproconazole, C63 - Lambda-cyhalothrin, D25 - Diuron, D55 - Dinotefuran, F68 - Fluxapyroxad, G01 - Glyphosate, H02 - Hexazinone, I32 - Isocycloseram, M02 - Mancozeb, M31 - Metalaxyl-M, M38 - Milbemectin, P05 - Pendimethalin, P13 - Profenofos, P61 - Pyroxasulfone, S13 - S-Metolachlor, and T24 - Triflural on the Monograph List of Active Ingredients for Pesticides, Household Cleaning Products and Wood Preservatives, published by Normative Instruction 103 on 19 October 2021 in the Brazilian Official Gazette (DOU - Diário Oficial da União).
