Description of content: This Draft Uganda Standard applies to kiwifruit (also known as actinidia) of varieties (cultivars) derived from <i>Actinidia chinensis</i> Planch and <i>A. deliciosa</i> (A. Chev.) C.F. Liang & A.R. Ferguson and hybrids derived from at least one of them, from the Actinidiaceae family, to be supplied fresh to the consumer. Kiwifruit for industrial processing is excluded.
