Addendum

The following communication, received on 23 September 2024, is being circulated at the request of the Delegation of <u>Canada</u>.

Established Maximum Residue Limits: Broflanilide

The proposed maximum residue limit (PMRL) document for broflanilide notified in G/SPS/N/CAN/1555 (dated 6 June 2024) was adopted 28 August 2024. The proposed MRLs were established via entry into the Maximum Residue Limits Database and are provided directly below:

MRL (ppm)¹ Raw Agricultural Commodity (RAC) and/or Processed Commodity

- 4.0 Leafy vegetables (crop group 4-13)
- 1.5 Leaf petioles vegetables (crop subgroup 22B)
- 0.7 *Brassica* head and stem vegetable group (crop group 5-13)
- 0.6 Dried tomatoes
- 0.2 Tomato paste
- 0.15 Fruiting vegetables (crop group 8-09)
- 0.07 Dry soybeans
- ¹ ppm = parts per million
