#### Addendum

The following communication, received on 1 October 2024, is being circulated at the request of the Delegation of <u>The Separate Customs Territory of Taiwan, Penghu, Kinmen and Matsu</u>.

The implementation of the "Quarantine Requirements for the Importation of Plants or Plant Products"

The Separate Customs Territory of Taiwan, Penghu, Kinmen and Matsu notified the draft of the "Quarantine Requirements for the Importation of Plants or Plant Products" on 14 May 2024 (G/SPS/N/TPKM/628) and 13 August 2024 (G/SPS/N/TPKM/628/Add.2). The regulation was published on 13 September 2024, and will become effective on 1 December 2024 (only the part of Melon necrotic spot virus, MNSV).
