According to our assessment, aggregate exposure will exceed the limit of ADI if the CAA accepts the Codex MRLs for these commodities, making the CAA disregard the new MRLs. Instead, we have established the MRLs for the commodities using the maximum dietary burden of the respective animals from the EU list, the highest value among five major countries. As a result, the CAA is able to make sure that an adequate margin of exposure exists for ADI and ARfD. Thus the CAA concludes that there is a reasonable certainty that no harm will be caused to our general population, or specifically to infants and children, from aggregate exposure to the residues of Fluopyram.</p>
