The following communication, received on 13 November 2024, is being circulated at the request of the Delegation of <u>Canada</u>.

## Established Maximum Residue Limits: Cyclaniliprole

The proposed maximum residue limit (PMRL) document for cyclaniliprole notified in G/SPS/N/CAN/1541 (dated 15 December 2023) was adopted 7 November 2024. The proposed MRLs were established via entry into the Maximum Residue Limits Database and are provided directly below.

## MRL (ppm)<sup>1</sup> Raw Agricultural Commodity (RAC) and/or Processed Commodity

- 1.5 Peppers/Eggplants (crop subgroup 8-09B)
- 0.7 Tomatoes (crop subgroup 8-09A)
