Established Maximum Residue Limits: Pyriofenone

The proposed maximum residue limit (PMRL) document for pyriofenone notified in G/SPS/N/CAN/1534 (dated 12 October 2023) was adopted 19 November 2024. The proposed MRLs were established via entry into the Maximum Residue Limits Database and are provided directly below:

- 2.0 Peppers/Eggplants (crop subgroup 8-09B)
- 0.2 Tomatoes (crop subgroup 8-09A)
